Ref. pre-page:- As enquired on prepage regarding scrutiny of validity of link licences & other documents. It is submitted that as per existing renewal process "there is no workflow for approval of restaurant renewal ARN. After the payment is successful, the status of the Renewal ARN changed to 'deemed renewed' (Copy of circular dated 12.02.2018 at P-191-194/c).

Besides above, the existing licensees are required to fill and complete the 'Provide Additional Details' form by going to the following link: License → Provide Additional Details."

Only the following documents will be mandatory to upload by Restaurant Licensees in 'Provide Additional Details' in addition to affidavit form which will have to be filled and completed by the Restaurant Licensees as part of the 'Provide Additional Details' functionality:

1. Copy of Insurance against Fire & Natural Hazard.
2. Fire NOC (mandatory for 50 seat covers and above for L17/17F, L18/18F & L19/19F),

Rest all of the documents are optional to be uploaded by Restaurant Licensees in 'Provide Additional Details' functionality.

However, the onus of obtaining the link licences has been put on the licensees as the 'deemed renewal' is conditional and subject to the fact that if any of the linked licences/permissions are cancelled, the Excise licence will be deemed cancelled (P-187/c).

Keeping in view the above, the file is re-submitted for further necessary directions in the light of notice received from ACP, Licensing, Delhi Police, 1<sup>st</sup> Floor, P.S. Defence Colony, New Delhi served upon M/s 4<sup>th</sup> Dimension (A Unit of Manas Entertainment) A-19, GF, FF, Vishal Enclave, Rajouri Garden, Delhi.

Out of above noted eating houses, the eating houses mentioned at Srl. No. 3, 4, 5, 7, 8, 15 and 17 also possess licences granted by this department although the licences granted to eating house mentioned at srl. No. 5 (P-62/c), 7(P-61/c) and 17 (P-71/c) were valid only upto 30.09.2018 but the licences granted to the eating houses mentioned at 3 (P-63/c), 4 (P-65/c), 8 (P-67/c) and 15 (P-69/c) are still valid having validity upto 31.03.2019.

In addition to above, some other correspondence is also received from the Delhi Police wherein they have informed about the non submissions of renewal application by the various eating house licensees as per details and status on P-72-~~67~~/c.

**PROPOSAL:-**

1. The application under ARN 'provide additional details' should only be allowed to be submitted on ESCIMS portal once the licensee uploaded copies of licences issued for previous financial year e.g. if the licensee is applying for renewal of excise licence for the year 2019-2020, he should upload copy of licenses issued by link department for the year 2018-19 alongwith copy of renewal application submitted in concerned department for the year 2019-2020. Although this ARN of 'provide additional details' shall have no effect on renewal of licence, but transport permit (TP) of the licensees shall be made subject to submission of said ARN of 'provide additional details' the date of which has been fixed for 15.04.2019 (P-9/N ante).
