CIRCULAR

Rule 89 of The Delhi Excise Rules, 2010, provides as under:

"The licensee shall always be bound to keep a minimum stock of liquor as may be laid down from time to time by the Excise Commissioner. Failure to build up and to maintain the minimum stock of liquor and failure to maintain its regular supplies as specified by the Excise Commissioner, from time to time and/or failure to supply liquor within time, which the Excise Commissioner deems reasonable, shall render the licensee liable to pay such penalty as prescribed".

Further, as per the terms and conditions of the L1 license for the year 2016-17 at clause 7.3 (c) *"the licensee shall keep one week's stock in his bonded warehouse at all time, of all the brands approved for sale in the National Capital Territory of Delhi so that uninterrupted supply to the retail vends/outlets can be maintained throughout the licensing year. In case, the licensee fails to maintain the required stock, action under section 16, 17 and other relevant section of the Delhi Excise Act 2009 shall be taken against him".*

Accordingly, all L1 licensees are hereby directed to maintain at least one week's stock of all the brands approved for sale in National Capital Territory of Delhi and submit weekly stock position on first working day of the week to the Asstt., Commissioner (Excise), through ESCIMS.

This issues with the approval of Excise Commissioner.
