CORRIGENDUM

In partial modification to the office order No. 2(11)/Ex/R/Misc/2017-18/1325-32 dated 26.08.2019, the provisions of the aforesaid order shall be applicable w.e.f. 01.10.2019 with the following amendments:


Srl. No. 1 of the order dated 26.08.2019 would be applicable only for the category of Champagnes/Sparkling wines. The time limit at the bar counter for the same shall be 3 days only.

Srl. No. 2 of the order dated 26.08.2019 would be applicable only on the category of Whisky & Vodka in price range of Rs. 1501- Rs. 4500/- for 750ml pack size. For a different pack size the MRP shall be adjusted proportionately. The time limit at the bar counters for the same shall be 8 days only.

In addition to above the following are exempted from the purview of the order dated 26.08.2019.

1. All licensees holding L-15/L-15F licence.
2. Hotel Restaurants (L-16/16F) running under unified Licence ID of Hotels having star categorization of 4 star and above, issued by Ministry of Tourism, Govt. of India.
3. One sealed bottle of each brand kept at the approved bar counter(s) for information of the consumer.

Further, it is clarified that the order dated 26.08.2019 restricting the time for disposal of liquor shall not be applicable on the liquor stock lying at the designated liquor stores i.e. L-16, L-16F, L-17, L-17F, L-18, L-18F, L-19 and L-19F.
