

Changes implemented in ESCIMS on Oct 10, 2018 for Duty Free Transport Permit (DFTP).

1. L32 / Registered Dealer log into ESCIMS and go to 'Duty Free TP -> View Application' to enter dispatch details of Duty Free TPs which are generated.
2. L32 / Registered Dealer click on 'Duty Free TP Number' (Fig 1) and enter mandatory details- Truck Registration Number, Driver Name, Driver Phone Number and Dispatch Date and clicks 'Save' (Fig 2 & Fig 3).
3. After saving details system will show 'The dispatch details have been saved successfully' (Fig 4).
