- L32 / Registered Dealer click on 'Export Permit No' (Fig 1) and enter mandatory details- Truck Registration Number, Driver Name, Driver Phone Number and Dispatch Date and clicks 'Save' (Fig 2 & Fig 3).
- 3. After saving details system will show 'The dispatch details have been saved successfully' (Fig 4).
