

Changes implemented in ESCIMS on Oct 10, 2018 for Transit Transport Permit(TTP)

1. L1-F logs into ESCIMS and goes to 'Transit Transport Permit → Print TTP' to print TTP which are generated.
2. L1-F click on 'TTP Number' (Fig 1) and enter mandatory details- Truck Registration Number, Driver Name, Driver Phone Number and Dispatch Date and clicks 'Save' (Fig 2).
3. After saving details system will show 'The dispatch details have been saved successfully' (Fig 3).
4. L1-F will print the TTP. Sample of Transit Transport Permit is shown in Fig 4.
