
**Sub: Implementation of provisions of Juvenile Justice (Care and Protection of Children Act, 2015-regarding.**

National Commission for Protection of Child Rights, Govt. of India vide their letter No. 2801/07/2016-Media/NCPCR/Vol.II/57959 dated 12.07.2017 has requested to issue directions under section 78 of the Juvenile Justice Act, 2015, which prohibits issuing a child for vending/peddling/carrying/supplying or smuggling any intoxicating liquor, narcotics drugs or psychotropic substance. Further, section 77 of the said Act, provides severe punishment attached for misuse of children for the said purposes. A copy of the said letter is enclosed.

Accordingly, all concerned licensees/ persons are hereby directed to follow the above stated provisions of the Juvenile Justice Act, 2015, in the letter and spirit.



Complaise

The National Commission for Protection of Child Rights (NCPCR), a statutory body established under the Commissions for Protection of Child Rights (CPCR) Act, 2005 (amended by the Protection of Children) Act, 2015.

2. The Commission has taken a *suo motu* cognizance of an incident published in the newspaper of India on 7<sup>th</sup> July 2017 'Hyderabad worries as drug racket networks students'. In the above newspaper, Director (Enforcement), Hyderabad stated that the peddlers used to sell route drugs. The students of top 25 premier schools and 20 top colleges were customarily gang that was selling LS (lysergic acid diethylamide), commonly called acid and (methylene-dioxymethamphetamine). The students are being misused by drug racketeers. The situation is very alarming.

3. The Juvenile Justice Act, 2015 contains provisions under Section 78 prohibiting a child for vending, peddling, carrying, supplying or smuggling any intoxicating liquor or drug or psychotropic substance while section 77 states the severe punishment attached for children for these purposes.

5. In view of above, it is requested that necessary directions may please be issued to the concerned to ensure effective implementation of the above provisions of the Juvenile Justice Act for checking this menace before it is too late. It is also requested that this Commission please be apprised about the action taken in the matter by your Department.
