ORDER

WHEREAS, a L-6 licence was granted to M/s DTTDC Ltd. for retail vend of liquor at K.No.8/3/1, Village, Johripur, alias Jiwanpur, Shahdra, Delhi

AND WHEREAS, the Hon'ble Supreme Court of India in the matter "The State of Tamil Nadu & Ors Vs K. Balu & Anr. with Civil Appeal No.12167 of 2016, 12168 of 2016, 12169 of 2016 & Civil Appeal No. 12170 of 2016 order dated 15.12.2016 under Article 142 of the constitution, has, *inter alia*, directed that:-

(i) All States and Union Territories shall forthwith cease and desist from granting licences for the sale of liquor along national and state highways;

(ii) The prohibition contained in (i) above shall extend to and include stretches of such highways which fall within the limits of a municipal corporation, city, town or local authority;

(iii) The existing licences which have already been renewed prior to the date of this order shall continue until the term of the licence expires but no later than 1 April 2017;

(iv) No shop for the sale of liquor shall be (i) visible from a national or state highway; (ii) directly accessible from a national or state highway and (iii) situated within a distance of 500 metres of the outer edge of the national or state highway or of a service lane along the highway.

AND WHEREAS, the District Magistrate, Ghaziabad has informed vide letter dated 22.03.2017 that your vend falls within the ambit of the order of Hon'ble Supreme Court of India,

AND WHEREAS, Sh. Shiv Kumar, Manager (Liquor) DTTDC and Sh. Ravi Kiran, Manager (IMFL), appeared before the undersigned on 30.03.2017 at 1 P.M. and raised no objection to the notice dated 29.03.2017.

Now, therefore, in compliance to the direction of the Hon'ble Supreme Court order dated 15.12.2016 I, Deputy Commissioner (Excise)/ Licensing Authority, hereby order for closure of your vend functioning at K.No.8/3/1, Village, Johripur, alias Jiwanpur, Shahdra, Delhi w.e.f 01.04.2017.
