CIRCULAR

The Government has taken serious view about drinking in open by some people in vicinity of the liquor vends. Therefore, the following has been decided:

1. To curb the activity of open drinking in vicinity of liquor vends, it was decided that CCTV Cameras with a minimum coverage of 50 yards and archival period of 30 days be installed at all the liquor vends in the GNCT of Delhi.
2. In this regard the necessary directions have already been issued vide Circular order No.10(155)/Ex/IMFL/10-11/Part-file/1363, dated 27.06.2011, the main point reiterated as under:-
  - (i) *The holders of L-6,L-7,L-8,L-9,L-10 and L-12 licences shall install CCTV cameras with a minimum coverage of 50 meters in and around the retail vend and archival of period of 30 days coverage for close monitoring of the activities around the liquor shops so as to assist regarding maintenance of law and order and public safety around these premises.*
3. As the number of complaints regarding incident of drinking in open in vicinity of the retail vends, have increased immensely, therefore, it has been decided that if any complaint is received against licence holders of L-6, L-6FG, L-7, L-7FG, L-8, L-9, L-10, L-12, L-12F, L-22 from any RWA or any citizen, the Deputy Commissioner (Excise) shall call for the CCTV footage of the licensee and if the complaint of consuming liquor in public places is found true or if the licensee fails to maintain CCTV footage, the Deputy Commissioner shall initiate action for shifting/ cancelling/suspending licence of the concerned licence holder under the Delhi Excise Rules.
4. The holders of license L-6, L-6FG, L-7, L-7FG, L-8, L-9, L-10, L-12, L-12F, L-22 shall arrange adequate manpower like security guards and deploy them to desist the people drinking in open in vicinity of retail vend.

5. In view of the above, all the retail licence holder inform of L-6, L-6FG, L-7, L-7FG, L-8, L-9, L-10, L-12, L-12F, L-22 are hereby directed to strictly adhere to the directions given in the circular dated 27.06.2011 referred above with regard to coverage and safe keeping of CCTV footage, otherwise strict action including shifting/ cancelling/ suspending licence under the provisions of Delhi Excise Act, 2009 and Rules, 2010 would be taken for non compliance without any further notice.
