Sub: Regarding the requirement of FSSAI License for all license holders.


Respected Sir,

It is most respectfully submitted that Food Safety and Standards Act, 2006, Rules and Regulations 2011, has been implemented in the State of Delhi w.e.f 05.08.2011. Under this Act Alcoholic drinks are also classified as food, and under this law, all Food Business Operators (FBOs) are required to obtain a license from this office. A copy of definition of food as provided in the Act is annexed Flag-1 and the requirement of License is given as Flag-2.

As such it is requested that all the licensees under your control including the retailers (whether Govt. or Otherwise), godowns, Distributors and the Manufacturing companies may be directed to obtain the license from this office. The manufacturing companies are also required to print the FSS License on the wrapper of the bottles along with the logo of the FSSAI.

It is also requested that a complete list of all licensees (both Govt. and Pvt. Vendors) may please be provided at your earliest, so that in case of non compliance of the above provisions of law (regarding obtaining the license from this Department) we may issue notice to individual license holders.

This issues with the prior approval of Commissioner Food Safety.
