**CIRCULAR**

Attention is invited to this office circular No.F.1(Misc.)/L-12/Ex/2015-16/659 dated 22.5.15 and subsequent order No.F.Ex/L-12/2015-16/Misc./94-L-12 dated 21.12.2015.

It is brought to the notice of all L-12/L-12F Licensees that same Departmental Stores were found violating the following terms and conditions again and again for grant of L-12/12-F License:

- (1.) The Departmental Stores were using more area than prescribed 10% (L-12) and 15% (L-12F) of carpet area for sale/storage of Beer & Wine in violation of Para 5.7 (A) and (B).
- (2.) Stores were not engaged in selling minimum six categories of items as per Para 2.1 which is reproduced as under:

**Explanation:** - Departmental store should have carpet area of at least 500 (Five Hundred only) Sq. Feet (excluding the office space) and should have different segments of minimum six categories of goods out of the following indicative list of categories.

- (i) Grocery Items,(ii) Vegetables (iii) Frozen Foods, (iv) Sugary & Bakery Items, (v) Toiletries, (vi) Cosmetics,(vii) House hold Goods (viii) Toys, (ix) Sports Items, (x) Electronic Appliances, (xi) Apparels, (xii) Office Stationery, (xiii) Any other Goods.
- (3.) Permanent Chiller were found installed and refrigerators were being used with capacity far in excess of prescribed 300 Ltrs. In violation of Para 5.7 (C). In many cases.
- (4.) Para 5.8 provides that the applicant shall submit monthly statement as prescribed in Form 11, of sale of Beer / Wine and other products separately by the 7<sup>th</sup> day of every following month, but most of the L-12/12-F departmental stores failed to provide the same.

All the L-12/L-12F Licensees are therefore, once again directed to strictly comply the laid down terms & conditions of L-12 and also provide details of sale of 06 departmental store items in monthly return separately and details of 06 departmental store to be shown in stock register separately, which will to be verified by the department time to time. Non compliance of the direction will be viewed seriously and strict action including suspension/cancellation of the Licence under Section 17 of Delhi Excise Act, 2009 will be initiated.
