CIRCULAR

Attention of licencees L-28/L-29 is drawn to the conditions dealing with the Retail licences for consumption 'on' premises laid down in Rule 51 of the Delhi Excise Act, 2009. Rule 51(10) interalia provides for furnishing the following documents, besides other mandatory requirements, issued by the concerned agencies.

- (a) Eating House Licence
- (b) Health Trade Licence
- (c) Certificate by the Tourism Department, Govt. of India/ Govt. of Delhi

(d) Site plan, prepared by registered architect.

(e) NOC from Fire Department

Vide order dated 24.7.2015 the decision of the Government has been conveyed to do away with the procedure of submitting the abovementioned linked licences. A copy of proforma of said affidavit is enclosed.

However, it is clarified that the onus of obtaining the Licenses from the linked Departments remains with the Licensee. In case any of the Linked Licenses/Approval /NOC is withdrawn/cancelled/ terminated, the Excise License shall also be liable for cancellation.

From the current year all the Licensees are required to submit only the following documents for renewal of L-28/L-29 Excise Licenses.

Copy of duly signed online ESCIMS generated renewal application.

Copy of original ESCIMS generated challan deposited for payment of license fee. ii) iii)

Affidavit as per proforma enclosed

Valid insurance of the premises against fire and other natural hazards. iv)

Certificate in favor of authorized signatory with specimen signatures and contact V)

Original L-28/L-28F or L-29/L-29F license. vi)
