

FREQUENTLY ASKED QUESTIONS (FAQ) FOR P-10 PERMIT

Qus. What is P-10 Permit?

Ans. The P-10 Permit is a Permit for service of Indian Liquor and Foreign Liquor at Personal/Private Party to be held at Residential Place, Community Centre, Banquet Halls, Farm Houses and Party Places etc.

Qus. How can P-10 Permit be issued?

Ans. Through Authorized Liquor Vend of L-6 and L-10.

Qus. What are the Terms & Conditions for P-10 Permit?

Ans. (a) The area should be screened off from Public View.

(b) Liquor is to be served only to adults above 25 years of age.

(c) Liquor has to be procured from Licensed source in Delhi and shall produce purchase voucher on demand.

(d) Liquor can be purchased from maximum of 3 vends before the start of event.

(e) The applicant shall ensure that a computer generated bill for liquor along with details of barcodes is given by the retail vend. The applicant can check the status of barcodes on the mobile application (mliquorsalecheck). If anything contrary is found by the inspection team, action will be taken against the P-10 Permit holder.

(f) For leftover stock more than possession limit of an individual specified under clause (a) of sub rule (1) of Rule 20 of Delhi Excise Rules, 2010, the applicant must apply for L-30 License in the Excise Department within 07 days of the event.

(g) If liquor is served outside the residence, P-10 Permit shall be obtained even if the quantity of liquor to be served is equal to or less than the possession limit of an individual specified in clause (a) of sub rule (1) of Rule 20 of Delhi Excise Rules, 2010.

Qus. What is the fee structure for P-10 Permit?

Ans. Rs. 10,000/- for private/personal function to be held at Residential Places or Community Centre and Rs. 15,000/- for private/personal function to be held at other than Residential Places or Community Centre i.e. Banquet Halls, Farm Houses and Party Places etc.

Qus. What are the payment modes?

Ans. Applied through authorized vend:- Online & Offline mode

Qus. How many guests can be served in a P-10 Permit?

Ans. As desired by the Permit holder and further restriction of the Government time to time.

Qus. Which places are prohibited for issuance of P-10 Permit?

Ans. School and religious places.

Qus. What is the minimum prescribed age for obtaining P-10 Permit?

Ans. Above 25 Years.

Qus. How much liquor can be purchased on a P-10 Permit?

Ans. As per applicant requirement of guests & restriction as per Rule 20 of Delhi Excise Rules, 2010.

Qus. From where the liquor can be purchased on P-10 Permit?

Ans. Maximum 3 Authorized Vends.

Qus. Can an applicant return the liquor which were purchased on P-10 Permit?

Ans. Yes, same day of purchase.

Qus. How much stock can be hold after the completion of event?

Ans. If permissible limit exceeds, applicant should apply for L-30 within 7 days of event.

Qus. What is the validity of P-10 Permit?

Ans. Six Hours (up to midnight).

Qus. Can liquor be purchased from outside Delhi on a P-10 Permit?

Ans. No, the liquor can be purchased only from the Vends authorized by Excise Department, GNCTD
