SHOW CAUSE NOTICE

Whereas, L-6 license was granted to M/s DCCWS, for its vend at Shop No. 4058, Roshanara Road, Delhi, for retail sale of Indian Liquor under the provisions of Delhi Excise ACT, 2009, Delhi Excise Rules, 2010 and terms and conditions framed thereunder.

And whereas, vide DDMA order no. . F.2/07/2020/pt.file-III/381 dated 19.04.2021, curfew on movement of individuals in the territory of NCT of Delhi was imposed w.e.f. 10 P.M. on 19/04/2021 to 05.00 A.M. on 20/04/2021. Accordingly, all the liquor vends in Delhi were also closed. The above curfew was further extended vide different DDMA orders till 14/06/2021.

And whereas, in pursuance of DDMA Order dated 05/06/2021, all liquor vends in Malls, Market complexes and Markets (outside containment zones) were allowed to operate on odd even basis between 10.00 A.M. and 8.00 P.M. vide Excise Department's order dated 06/06/2021. Further, all the retail liquor licensees viz. DSIIDC, DTTDC, DCCWS & DSCSC and L-7, L-9 and L-10 were directed to deploy adequate staff at their vend to ensure Covid Appropriate behaviour viz. wearing a Masks, maintaining social distancing, regular use of Sanitizers, etc.

And whereas, in pursuance of DDMA Order dated 13/06/2021, all the liquor vends were allowed to operate daily between 10.00 A.M. and 8.00 P.M. vide Excise Department's order dated 14/06/2021.

And whereas, it has come to the notice of the Excise Department that social distancing norm was not maintained at Vend No. 4058, Roshanara Road, Delhi of M/s DCCWS.

And whereas, the said conduct of M/s DCCWS is violative of the instruction of DDMA orders, which attracts the provisions of Section 17(c) of Delhi Excise Act 2009.

Now, therefore, I Deputy Commissioner (Excise), deem it fit to suspend the L-6 license of M/s DCCWS at shop No. 4058, Roshanara Road, Delhi with immediate effect. M/s DCCWS is hereby directed to appear on 30.06.21 at 4 P.M. through an authorized representative alongwith written submission and requisite documents failing which appropriate action, under the Delhi Excise Act, 2009 and the Delhi Excise Rules, 2010 shall be initiated against the licensee without further reference.
