4. Valid NOC from DFS/ Affidavit reg. fire-fighting arrangements (in case of seating capacity of below 50 covers)

6. Excise Nominee for the year 2015-16
7. IT Return for the year 2013-14
8. DVAT Return for the year 2013-14
9. TR/Challan of licence fee deposited for the year 2015-16
10. Original Licence

The department reserves the right to review the licence fee and in case the same is increased, the licensee shall be liable to pay the increased amount within the stipulated time period failing which the Department shall have the right to stop the transport permit of the unit.

All requisite documents as stated above along with the application requesting for renewal of licence and the licence fee for the year 2015-16 must be submitted by **28.2.2015**. It may be noted that failure to adhere to the above schedule for applying for renewal of licenses may lead to non-renewal of licenses/ stoppage of transport permits.

Note: -As per **Rule 41 of Delhi Excise Rules, 2010**, "All applications for the renewal of licences and permits shall be received in the office of the Deputy Commissioner before the end of February each year alongwith licence or permit fee, payable for the renewal of licence or permit. In case of delay the Deputy Commissioner may admit such application before the expiry of licence or permit, provided that there are good and sufficient reasons for the delay on payment of additional fee of twenty-five percent of the prescribed licence or permit fee;

PROVIDED that the application for renewal of licence or permits may be admitted after the expiry of the licence or permit, if there are good and sufficient reasons for the delay on payment of double the amount of licence or permit fee payable, and the licence or permit may be renewed with the approval of the Excise Commissioner.

Further vide Notification F.10(3)/Fin(Rev-I)/2013-14 dated 6.8.2013 the following amendment in Rule 41 has been done.

"3. Amendment of rule 41.- In the Delhi Excise Rules, 2010 for rule 41, the following shall be substituted, namely:-

...Provided further that in case of licence in form L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F and L-18A/L-18AF, the licence fee is payable in two equal installments after completion of all documentary requirements. First installment of 50% of the licence fee should be paid before end of February each year, failing which additional fee of 25% of 1st installment shall be payable till 31st March and beyond that double the amount of 1st installment shall be payable. Second Installment of remaining balance amount of licence fees should be paid before 30th September each year alongwith interest @ 12% per annum failing which double the amount of 2nd installment shall be payable."

The Department reserves the right to review the nature of renewal of licences and any change in this regard shall be binding on the licensees.
