CIRCULAR

Subject: Renewal of License in form of L-11 for the period w.e.f. 01.04.2023 to 30.09.2023.

1. It has been decided by the Competent Authority to renew all existing L-11 for the period w.e.f. 01.04.2023 to 30.09.2023 on payment of proportionate license fee ON OR BEFORE 31.03.2023 for the said period subject to the following conditions:


a. All the licensees of L-11 are hereby directed to submit their application for renewal of license online by accessing their account in ESCIMS portal through their I.D. and password along with the applicable license renewal fee for the period w.e.f. 01.04.2023 to 30.09.2023 by providing the requisite information and payment of renewal license fee on or before 31.03.2023.

b. The Licensee should ensure that the licensed premises remains in his legal possession during the currency of licence as required under section 13 (1) (f) of the Delhi Excise Act, 2009. Accordingly, the license fee for the period w.e.f. 01.04.2023 to 30.09.2023 will be levied on proportionate basis for the period w.e.f. 01.04.2023 to 30.09.2023 on the fee structure as given below:

I. FEE STRUCTURE FOR L-17/L-17F LICENSES (Rounded off to nearest Rupee)

capacity (per day)	License fee for Excise year 2022-23 (extended period)	Propionate License fee for 06 months w.e.f. 01.04.2023 to 30.09.2023

upto 500 Ltr	250000	125000
upto 1000 Ltr	500000	250000

2. The Department reserves the right to review the license fee and in case the same is increased, the licensee shall be liable to pay the increased amount within the stipulated time period failing which the Department shall have the right to stop the transport permit of the unit or take any other suitable action.



3. All applications for renewal with license fee must be submitted online **ON OR BEFORE 31st March 2023**. The licensee should submit renewal application with fee by due date accessing their account in ESCIMS portal through their I.D. and password alongwith the acceptance of Declaration
