
**CIRCULAR**

**Sub: Transfer/shifting of Licensed retail vends in Shopping Malls(L-10)**

The competent authority is pleased to allow transfer/shifting of L-10 vends, subject to following guidelines:

- (i) Applications of only those vends, which have completed at least two years of their existence at one place, would be considered for transfer/shifting, except for cases where liquor vend is closing/has closed due to exigencies beyond the control of the licensee i.e. Act of God (force majeure), due to orders of any Government agency/Bank/Court etc.
- (ii) A transfer/shifting fee equal to the "Annual Licence Fee" for transfer/shifting from one place to another shall be charged.
- (iii) The application for transfer/shifting of vend from one locality to another would be decided within a maximum period of 60 days from the date of receipt.
- (iv) The other terms and conditions and provisions under the Delhi Excise Act, 2009, and Rules framed thereunder, for grant/renewal/shifting of licence would remain unchanged to such extent as modified above.

Therefore, any interested L-10 Licensee may submit its application for shifting of its L-10 vend from existing premises to another premises in the proforma enclosed as Annexure.






