Sub: Extension of License Period for sale of Liquor under L-1/L-1F and L-2 (Draught Beer) License up to 30.09.2023

In accordance with the provision of Rules 34 of Delhi Excise Rules, 2010, the Competent Authority has approved the extension of validity of existing L-1/L-1F/L-2 Licensees for the sale of liquor brands registered as per approved terms and conditions for 2022-23 at their existing price up to 30.09.2023.

The L-1/L-1F/L-2 Licensees who are willing to avail of this extension period of 06 months from 01.04.2023 to 30.09.2023 to make sales of their registered brands at existing price, are required to deposit 06 months' fee i.e. License fee, Label Registration fee, BWH fee and any/all other fees as applicable to L-1/L-1F/L-2 Licenses on pro-rata basis for a period of 06 months in advance.

However, any person holding such non-renewable license shall not be under any obligation to accept such offer to extend his license.
